average (GPA) overall of 2.75 or a master's or higher degree with a GPA of at least 3.0. For candidates who meet requirements for unconditional admission to an Alternative Master's program July 1, 2017, and thereafter, a minimum GPA of 3.25 is required on all courses used to meet the requirements on the approved program checklist for Alabama State Board of Education educator preparation program.
