Methods courses, practicum and internship require candidates to utilize technology in their instructional planning and analysis of student learning. The curriculum and instruction classes are created from the perspective that teachers must design instruction considering multiple approaches to meet the needs of diverse learners. Technology is also a crosscutting theme in CAEP and is a significant component of our self-study. Assessment classes also address the use of technology for assisting teachers with monitoring the progress of all students and planning for improvement.

Students in general education programs are taught a variety of methods and strategies for effectively teaching students with disabilities. Here are a few examples: teaching vocabulary strategies for better reading comprehension; reading intervention strategies; building lessons with particular mock students in mind; utilizing a universal design of learning; building lessons with students' individual needs at the forefront; how to prepare general education students for the addition of a child with special needs; the importance of classroom layout in order to show welcome and respect to the child as well as manage the classroom; placing an emphasis on ability vs. disability; how to build a network of stakeholders to assist the child; the importance of learning via professional readings to understand our role and responsibilities and better understand specific disabilities.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities*Education Act

Students are taught that they will be a vital member of the IEP team for students with disabilities in their classroom and a variety of strategies are used to help them understand their role as they participate. For example, sample activities include providing sample scenarios for a team; creating sample scenarios of a child with physical, emotional, cognitive learning need; having actual special education teachers or specialists meet with students as an informational event; holding Zoom sessions with specialists at different schools

c. Effectively teach students who are limited English proficient.

Examples of instructional strategies taught to our general education students to address their future limited English proficiency students in the classroom are as follows: reading vocabulary strategies such as use of pictures, examples, non-examples, and characteristics to describe new words; the value of cognates; the role of code switching in classroom instruction; culturally relevant pedagogical practices; the use of partnerships with parents, teachers, schools, administrators, and community stakeholders; the relevance of household visits; funds of knowledge theoretical model; the adverse effects of deficit thinking paradigm; how to build a teaching community that acknowledges and values cultural diversity; the importance of including minority families in school decisions and in the growth of the school, and in the value and mission of the school; how to create or use free websites that allow teachers to submit online lessons with supplemental resources and links; the value of having periodic workshops in which minority populations can become mentors to other newly arrived culturally diverse parents and families; include activities to determine alternatives for students with limited English proficiency; and activities to determine available resources to assist with creating lessons eith ELL students in mind.

a. Teach students with disabilities effectively

All special education programs have sequential coursework aligned with special education standards delineated by CEC and the ALSDE. In addition, methods courses, practicum and internship provide candidates multiple opportunities to collaboratively plan and reflect on lessons that address

students with disabilities. Council for Exceptional Children professional practice and ethical standards are addressed in each course to ensure teacher candidates are trained to teach students with disabilities effectively. High leverage practices in special education are incorporated into the coursework and integrated in multiple assignments such as a reading portfolio, mathematics portfolio, lesson planning, the use of differentiated instruction, behavior intervention plans. In addition, specific IRIS center modules that focus on inclusive practices are incorporated throughout the program. During practicums and internship (ESPE 4912, 4913, 4914, 4915, 4924/6924, 6914), teacher candidates have the opportunity to observe and practice evidence-based instructional and behavior management strategies.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Teacher candidates are initially taught to write entire IEPs through the use of case studies in multiple courses (ESPE 4200/6200, 4300/6300, 4040/6040, 4400/6400). Teacher candidates are provided practice with specific elements of an IEP (i.e., how to write standards-based IEP goals and benchmarks, how to interpret assessment data to develop annual goals and benchmarks, etc.). They also compose transition plans and plans for early childhood special education services. Teacher candidates explore the different types of assistive technology and related services for students with disabilities which must be included the IEP. Teacher candidates are taught collaboration skills necessary to participate as an IEP team member and other essential communication skills. During practicums and internship (ESPE 4912, 4913, 4914, 4915, 4924/6924, 6914), teacher candidates have the opportunity to participate in IEP meetings and/or reevaluation meetings. They also have opportunities to glean information from their students that they teach during practicums and internship.

c. Effectively teach students who are limited English proficient.

Teacher candidates learn about different types of diversity, including linguistic diversity, and effective strategies for teaching those populations in ESPE 3760 Survey of Exceptionalities or ESPE 6100 Students with Special Needs. Teacher candidates also complete IRIS Center modules related to diversity in ESPE 3760, 6100, and 6800. Special education teacher candidates complete a series of practicums and an internship that allow for the teaching of students with a wide range of abilities from birth to 12th grade.
