Enrollment: recruitment, retention, and student engagement:

Increased real enrollment (enrollment after accounting for miscoded students and organizational changes) in
 the School of Liberal Arts by 10% Fall 2009-Fall 2014, in a period when overall university
 enrollment decreased 9%. Real enrollment in College of Arts and Sciences remained flat

(increased 0.1%) Fall 2015-Fall 2017, in which period overall university enrollment decreased 0.5%.

Established *A Taste of College*, a program in which high school students visit classes and receive career advice regarding liberal arts fields, thus fostering college readiness and AUM recruitment.

Instituted Fall convocations for adjunct faculty, one with lunch, one with dinner, in order to apprise adjunct faculty of new policies that affect the classroom (including retention policies) and better socialize them into the university. Adjunct faculty teach a large portion of freshmen and sophomores, who are most at risk for attrition. The adjunct faculty were very appreciative. This practice has now been adopted by the University's central administration.

Established an area, equipped with desks and computers, for adjunct faculty to meet with students.

Established a student service group in the School of Liberal Arts and then in the College of Arts and Sciences. These students serve the School/College in various ways, engage in community service projects, and talk to prospective students.

Aggressively supported institution of campus retention measures by inviting retention officers to address School/College convocation regarding early warning systems and publicly supporting them in other venues with the School's/College's faculty.

Established dean's list ceremony in School/College with invitations to entering freshmen.

Lowered withdraw, drop and failure rate in University Core courses (within the College of Arts and Sciences) by five percentage points, Fall 2015-Fall 2017. Core Math WDF rate lowered by 13 percentage points in that time.

Resolved chronic problem of shortage of seats in University Core Mathematics courses, Fall, 2016.

Established special mentoring program for teaching with strictly formative peer review for new faculty.

Establishment of new academic programs, including interdisciplinary programs in the School of Liberal Arts. This work involved a call to the faculty for proposals, assessment of demand for the programs and resources required, working with faculty to develop curriculum and, in the case of some interdisciplinary programs, gaining cooperation of other deans:

Master of Teaching of Writing, an interdisciplinary program drawing on coursework in English, Business, and Education.

Graduate Certificate in the Teaching of Writing.

Bachelor of Science in Communication Disorders.

Bachelor of Fine Arts (in addition to standing Bachelor of Arts in Visual Arts)

Undergraduate Chinese and East Asian Studies track in the Bachelor of Arts in World Languages and Cultures. This was made possible by gaining support from AUM's Confucius Institute for an additional instructor and funds for library purchases.

Undergraduate Certificate in American Society and Culture, aimed at international students.

Undergraduate Religious Studies track in the Bachelor of Liberal Arts, an interdisciplinary program drawing on coursework from the former School of Liberal Arts and the former School of Sciences.

Undergraduate Photography track in the Bachelor of Arts of Fine Arts.

Online education: led the strategic establishment of academic programs online while maintaining their bricks and mortar versions.

Public Service and Community Engagement:

- Established *Scholars Without Walls* in the School (then *Scholars to Go* in the College), a speakers' bureau placing faculty as speakers with community groups and high schools, with more than 2,500 people thus addressed annually.
- Established "Professors in Pubs," a speakers program.
- Increased average annual donations to the School of Liberal Arts and its departments by 54% during my tenure as dean.
- Established the *Athena Society*, a "donor's club" for the School of Liberal Arts and College of Arts and Sciences.
- Re-established the School of Liberal Arts' Advisory Council, an advisory group of community members. The Council regularly gives useful advice. Established an Advisory Council for the College of Arts and Sciences.
- Established an annual fundraising event for the School of Liberal Arts (now for the College of Arts and Sciences), *A Night Out*.
- Shepherded donation of television studio/lab, with subsequent upgrades, by Raycom Media and donations of architectural and construction services for the studio by Brown Chambless Architects and W.K. Upchurch Construction.
- Established a contract to operate a writing center for master's students at the Air War College, Maxwell Air Force Base. When sequestration forced its closure, the Air War College found donated funds to renew the contract.

Internationalization:

- Handled end negotiations for 3+1 agreement with Central South University of Forestry and Technology (China) for degree in Environmental Science and for proposed dual degree program in Environmental Science.
- Negotiated with Hubei University of Economics (China) to articulate core curriculum for proposed dual degree program in Business.
- Negotiated student and faculty exchange agreement in English and History with University of Lincoln (United Kingdom). History agreement accomplished.

Resources and Budget:

- As dean of the School of Liberal Arts: obtained approval for searches in 20 full-time faculty positions (including six new ones, losing one position), 2009-2014, when state appropriations fell by 19% (2008-2014).
- As dean of the College of Arts and Sciences: obtained approval for searches for 21 full-time positions (including seven new ones, losing two), 2015-17, when overall university revenue was flat.
- Oversaw various external grants to units and faculty within the School of Liberal Arts and College of Arts and Sciences, including AUM's first National Science Foundation grant.
- Established a laboratory for the new photography track in the B.A. in Fine Arts.
- Established a mini-language laboratory, with financial support from AUM's Confucius Institute.
- Largely completed establishment of a new small research building for the natural sciences.
- Negotiated moving the self-supporting Speech and Hearing Clinic to an improved off-campus facility with rent still covered by the University.
- Established an internal grants program in the School of Liberal Arts for faculty scholarship, student activities, community outreach, and visitors to campus, in order to commit funds with a more synoptic view of needs and opportunities. The program with modifications continued in the College of Arts and Sciences.
- Finished every fiscal year with the budget in a positive balance.
- Provided key information on departmental expenses in negotiation of a new funding formula for academic units and negotiated with the other deans to produce a yet newer formula to replace it.

- All but established, with the Offices of Student Affairs and Diversity, College of Arts and Sciences Scholar of Diversity in Residence program. Unfortunately, budgetary trouble derailed implementation at the last minute.
- Ex officio, took part in various meetings/committees to produce the University’s new strategic plan; served on strategic planning subcommittee for faculty scholarship/research.
- Ex officio, sat on University Tenure and Promotion Committee for two years until the Faculty Handbook was revised to release deans from service on the Committee. This work gave me a window on academic matters throughout the campus.
- Established a system for peer review of teaching, employing a faculty advisory committee in doing so.
- Oversaw creation of benchmarks for tenure where departments did not have them.
- Re-established the annual *Auburn University at Montgomery Liberal Arts Conference* as an annual conference on *Southern Studies*. This move raised the university’s profile, converting a conference drawing participants solely from central Alabama to one drawing participants (in 2015) from 18 states, two countries, and thirty-seven institutions.
