In 2024, Cognella Publishers invited me to write a review of one of their publications, “The Criminological Theories.” At the end, they made me a offer to write a book for them in the area of cybercrime and victimization and cyber security.

I negotiated with them and agreed to write a textbook in the area of cybercrime and security. Book work is mostly complete. However, Cognella has it’s own timeline and process. But, cybercrime and security is a fast growing area. I think book will become available in early 2026.
