July 2013-June 2016 Associate Vice Chancellor for Enrollment, University of North Carolina at Pembroke

The AVC for Enrollment reports to the Provost and is the university's enrollment manager, responsible for meeting recruitment and retention goals and interfacing with the UNC General Administration on all matters of enrollment management, including developing the annual enrollment projections that determine the university's state-appropriated budget. At its peak the unit comprised twelve university offices with 74 full-time employees and a total state and non-state budget around \$8 million: Undergraduate Admissions, Financial Aid, the Registrar, the Academic Support Center, the Advising Center, First Year Programs, New Student Orientation, TRIO, disability support, and other academic support offices. The AVC hears undergraduate student requests for overloads, late withdrawals, and assistance with registration and financial issues. Most importantly, the AVC serves as an advocate for both recruitment and academic support services, bridging the gap between faculty and staff perspectives.

Major Initiatives and Accomplishments

Recruitment and Retention

- Presided over new freshman recruitment increase of 17.4% since 2013; enrolled our largest freshman class in history in Fall 2015
- Oversaw changes to transfer recruitment, admissions, and orientation process that resulted in a record new transfer class in Fall 2014, an increase of 19% over the previous year; sustained this larger number with a 1% increase in Fall 2015
- Led retention initiatives throughout the academic support offices reporting to Enrollment, with a 68.2% first-time full-time fall to fall retention rate in Fall 2014; the rate is on track to improve to 70% or higher in Fall 2016
- Revised the appeals process by which academically suspended students or those who have lost financial aid eligibility can regain their status, using a single unified intake in the Academic Support Center to ensure students' exposure to the support services they will need if their appeals are successful; served as chair of the Academic and Financial Aid Appeals Committee

Strategic Planning and Partnerships

• Conducted the university's enrollment planning process as chair of the Strategic Enrollment Planning Team, bringing together staff and faculty from across the campus to write the annual Strategic Enrollment Plan and form work groups to carry out action plans for specific objectives

- Led Admissions, Financial Aid, and Honors College in continuous revision and execution of merit scholarship award process and financial aid packaging to leverage use of aid in increasing enrollment yield, particularly of Honors students and high-achieving Native American students; approximately \$58 million annually is awarded from federal, state, and institutional sources
- Worked closely with Bursar each semester in developing criteria for use in dropping students for non-payment, to minimize both enrollment melt and Accounts Receivable
- Worked in partnership with Advising, Distance Education, deans and department chairs to ensure
 that enough sections and seats are available for incoming students each semester; initiated
 conversations to develop a strategic course scheduling process taking continuing students into
 account as well, for most efficient allocation of adjunct budget
- Reviewed the course schedule each semester to ensure that departments were covering time slots equitably and offering enough sections of General Education courses
- Chaired the Student Services Committee, bringing together the heads of eight student service offices across campus to resolve cross-divisional customer service issues and provide continuous improvement review of business processes
- Worked with Controller, Bursar, Budget Director, and Chancellor's office to develop a proposal for UNCP to be allowed to charge a lower "border tuition" rate to residents of South Carolina counties within 50 miles of Pembroke; this study compared our cost of delivering education and our available capacity to the rate of tuition the South Carolina market would bear

Governance and Policy

- Oversaw the process of achieving major academic policy change regarding academic suspension of new students; reviewed data, wrote policy language, and shepherded the changes through the Faculty Senate approval process as an ex officio member of the Senate's Enrollment Management Subcommittee (EMS)
- As member of EMS, led the university's policy response to several major mandates from the UNC General Administration, including the "Fostering Undergraduate Student Success" package of reforms in 2013-14, the "Transfer Student Success" regulations in 2014-15, and the "Military Student Success" regulations in 2015-16
- Led the university's response to the mandates contained in the UNC system's Comprehensive Articulation Agreement with the North Carolina Community College System, including the creation of baccalaureate degree plans, changes to policy, and changes to the Web site

Technology Initiatives

- Led the team tasked with selecting and implementing an electronic academic catalog software solution; Acalog has now been fully installed, and Curriculog implementation is in progress
- Advocated for the Registrar's projects to have a higher priority with the Division of Information Technology, leading to the decision to create fully digital processes for course and term withdrawals; led process of gaining faculty input about the implementation of new workflow
- Served as Academic Affairs lead on a large technology project to modernize course and classroom scheduling in Banner and EMS Campus; developed and negotiated procedures for classroom scheduling with academic deans and department chairs

Budgeting and Personnel Management

 Managed operating budget of Enrollment office, and oversaw budgets for reporting departments, with specific responsibility for ensuring that deficits in one office or budget holes created by end-of-year reversions were covered from within the resources of the division

- Led Enrollment offices in budget realignment process undertaken by central administration to free money for faculty salary raises in 2015, and a zero-based budget initiative in 2016
- Hired Registrar, Director of Academic Advising, and Director of Academic Support Center
- Chaired successful search committee for Dean of Library Services in 2016

June 2012-July 2013 Interim Assistant Vice Chancellor for Student Academic Support and Retention, University of North Carolina at Pembroke

This role was created during a university reorganization that split the former division of Enrollment Management into two units, grouping all retention services in one unit reporting to the Provost, with 30 full-time employees and a total budget of around \$4 million. The AVC served as chief retention officer. During the prior year I worked in Freshman Seminar improvement while still a faculty member.

Major Initiatives and Accomplishments

- Led reorganization and relocation of multiple offices into Student Academic Support and Retention unit housed in one highly visible campus location; the SASR name is still maintained for faculty outreach and internal coordination of offices
- Led campus outreach campaign advertising support services to faculty and staff via print, email, and personal visits to academic departments; the number of faculty using the academic early warning system increased from 41 in Fall 2011 (prior to the reorganization) to 180 in Fall 2014
- Oversaw the creation of a new office, the Advising Center, to centralize undecided student advising, First Year programs, and New Student Orientation under one organizational umbrella; in its first year this office developed a new overnight format for freshman orientation
- The first-time, full-time fall to fall retention rate rose from 62.4% in Fall 2011 (prior to the reorganization) to 67.6% in Fall 2013
- Member of Academic Integrity Ad Hoc Committee charged with implementing UNC Board of Governors regulations on "athlete clustering" and other athletic-academic misconduct; in 2014 and 2015 served as the designated Academic Affairs official performing the review of athlete registration and grade data mandated by the regulations
- Served as Academic Affairs lead on major IT project creating an electronic roster verification system used by faculty to indicate non-attending students after the first day of classes
- Reviewed and overhauled the record-keeping and budgeting practices of a large federal grant funding one of the SASR offices, and wrote the Annual Performance Report for the first year as Project Director
- Coordinated the SASR response to budgetary initiatives, including requests for end-of-year funding and allocation of earmarked funding from a Campus Initiated Tuition Increase in 2013
