Measures & Formats: The CPCE is a 160 question multiple choice online exam administered by the National Board for Certified Counselors (NBCC).

Analysis and Utilization: The program aggregates the scores to determine areas for program improvement within the 8 CACREP core areas.

Remediation: The individual student may be offered to either re-take the CPCE or to receive an alternate form of testing in areas of weakness. Patterns noted in the aggregated scores will be explored with faculty to determine areas for program

Q5 - Indicate which of the following applies to your current status.





Q6 - What degree in the Auburn Montgomery Counseling Program are you currently pursuing?





Q7 - How long have you been enrolled in the program?




