



5. Follow the College of Business on Social Media




Steps to Setup your AUM Email on your iPhone



- 1 Go to System Settings and select 'Mail,' then tap 'Accounts.'
- 2 Tap 'Add Account,' then tap 'Microsoft Exchange.'
- 3 Enter your name, email address, password, and type 'AUM Email' in description.
- 4 Tap Next to finish setting up.



Steps to Setup your AUM Email Using Gmail

Looking for a 3000/4000 or graduate level elective course to take in Fall 2022?

Register for one of the following new courses.

BUSN 4990 Research in Business

Prerequisites: minimum grade of C in QMTD 2750 and BUSN 3060; GPA of 3.2 or higher.

- Conduct original research on a business topic of your choice.
- The course is 3 credit hours, meets on campus, and is eligible for a 1-credit hour scholarship (see below). Dr. Harrington is the instructor.
- Open to all undergraduate Business majors who meet the prerequisites.
- This course may fulfill an elective requirement. Check with your academic advisor.

FINA 4970/6970 Special Topics: Business Analysis and Valuation

Prerequisites: Grade of B+ or higher in Principles of Financial Management (FINA 3610) or enrollment in the MBA program.

- Learn how the pros research companies to make investment decisions.
- You can choose 1 to 3 credit hours for the course and it is eligible for a 1-credit hour scholarship (see below). Dr. Hahn is the instructor.
- This course may fulfill an elective requirement. Check with your academic advisor.

Combine an Internship with an Internship Course

Prerequisites: 2.75 GPA and 60 earned credit hours for undergrads (the Marketing internship course also requires a grade of C or better in MKTG 3310); 3.0 GPA and 15 earned credit hours for graduate students.
