# **General Studies**

### The Auburn University Journal of Undergraduate Scholarship (AUJUS)

A peer-reviewed journal that showcases the top research and scholarly accomplishments of Auburn University undergraduate students. We are seeking original research from students in any academic discipline.

### EvoS Journal: The Journal of the Evolutionary Studies Consortium

Designed to promote the education of evolutionary theory in colleges and universities. An evolutionary education provides a framework for enhancing the research and theory in all disciplines, and as such, EvoS Journal welcomes work from all academic disciplines as well as interdisciplinary scholarship that incorporates evolutionary theory across areas of study. ### **Global Topics**

Global Topics is a peer-reviewed electronic journal published by the Thomas J. Dodd Research Center for International Affairs and Law, New Hampshire Institute of Politics at Saint Anselm College. In keeping with the Institute's mission, Global Topics seeks to publish the highest quality undergraduate writing. Papers can be from any discipline or a product of collaborative undergraduate/faculty research so long as they address international, transnational, global, or comparative issues. No length is required, but articles should not exceed 35 pages, and preference will be given to writing with contemporary relevance.

### The Honors Review

A nationally competitive interdisciplinary journal seeking illuminating, insightful and contemporary research at the undergraduate level. Students need not be members of Honors Programs to submit papers. The primary goal is to give all undergraduates the opportunity to participate in scholarly conversations within their disciplines and to expose them to the dialogue that occurs between a journal and a contributor in editing an article for publication. The Honors Review will provide its authors with the unique chance to receive prompt and personal feedback during the editing process through the use of private online discussion forums. ### Journal of Undergraduate Research

The JUR is interdisciplinary and accepts submissions which would meet the standard of excellence for students in diverse fields of study. Although most submissions are made by students participating in Minnesota State University, Mankato's Undergraduate Research Conference, submissions from any undergraduate student will be considered for publication. The JUR is published annually as an electronic journal.

### Journal of Young Investigators

JYI, Inc. is a exciting, student-led initiative to broaden the scope of the undergraduate scientific experience. JYI provides opportunities for students to participate in the scientific review and publication processes, primarily through the operation of its peer-reviewed journal for undergraduates. Incorporated as a non-profit, entirely student-run corporation, JYI's staff members currently represent over 30 different academic institutions. JYI has been featured in *EurekAlert!, Chemical Engineering News*, and *The Chronicle on Higher Education*. Recently, an article highlighting JYI appeared in *The New York Times*. Electronic only.

### The Kennesaw Tower

The only multi-lingual, multi-cultural, and multi-perspective on-line undergraduate research journal, students whose work had at one time gone unnoticed except by the eyes of their professor may now reveal the fruits of their academic labors to a world-wide readership.

### Lethbridge Undergraduate Research Journal

The Lethbridge Undergraduate Research Journal is an online journal for undergraduate students to publish their academic papers in. It is run by and for undergraduate students. The L.U.R.J. is international in scope, and welcomes papers from all undergraduates. Papers are accepted at all times. New issues are released approximately every 4 months.

### National Undergraduate Research Clearinghouse

Any unpublished research that was conducted when the author was an undergraduate student is eligible for submission. A registered faculty member must agree to sponsor the manuscript. Accepts any scientific manuscript. They can be empirical studies or literature reviews from any scientific discipline. The site encourages variety and an interdisciplinary approach.

### Pacific Northwest Journal of Undergraduate Research and Creative Activities

Pacific Northwest Journal of Undergraduate Research and Creative Activities is a peer-reviewed, open access journal dedicated to the publication of outstanding scholarship by undergraduates and their mentors from academic institutions of higher learning. Although the Journal is primarily intended for scholarly work from institutions in the Pacific Northwest, submissions from outside the region will also be considered. The Journal accepts submissions of research articles, fiction, poetry, photography, videos, and other creative works from undergraduate students in all academic disciplines. Submissions are accepted on a rolling basis and will be published on the Journal website after successful review.

### Pittsburgh Undergraduate Review

The purpose of the PUR is to advance innovative undergraduate scholarship. PUR is a multidisciplinary journal that accepts papers from around the world. The Pittsburgh Undergraduate Review has a rolling submissions process and accepts papers throughout the year. Multiple submissions are allowed. Papers submitted to the Pittsburgh Undergraduate Review may not be submitted to other academic journals during the review process.

### **Student Pulse**

Student Pulse publishes the academic work of students from leading universities in the U.S. and worldwide. Submissions are accepted on a rolling basis and over a wide range of academic disciplines. All submissions are carefully reviewed by our editors. If accepted, your work will appear alongside other high quality work within your discipline and be available to thousands of daily readers.

### SURJ: Stanford Undergraduate Research Journal

The Stanford Undergraduate Research Journal is an annual peer-reviewed publication of research articles written primarily by Stanford undergraduates, but also well-qualified students at other institutions, from all academic fields. [[Note: Please make sure you fill out and submit an Author Agreement Form along with your paper.]] The SURJ is an interdisciplinary journal published annually that seeks to provoke curiosity and intellectual exploration across both the Stanford community and at leading institutions nationwide.

# Science and Engineering

AJUR: American Journal of Undergraduate Research

A refereed international journal for undergraduate research in the pure & applied sciences, mathematics, engineering, technology, and related areas in education. Published four times each year in March, June, September, and December. Maintained by University of Northern Iowa, Department of Physics.

# ASDL

Invites the submission of manuscripts describing the results of undergraduate research in the analytical sciences. These articles can be submitted at the logical point of a student's involvement in a research project, even if the research is carried further by other students at a later date. While the scope and depth of the research described may not be at the same level as that of a major research institution, the quality and merit of the presentation should be.

# BIOS

BIOS, the quarterly journal of Beta Beta Beta Biological Society (MTSU - Kappa Delta), has been published continuously since 1930. Membership in BBB is NOT required for publication in BIOS. Purpose: to publish matters that pertain to the affairs of the Society, to publish articles by members, and to publish articles that will be of general interest to biologists. Many distinguished biologists have contributed manuscripts for publication in BIOS, written especially with the undergraduate reader in mind. Subjects covered include articles on current research, developments in biology, biology as a profession, as well as graduate and professional training for biologists. Special emphasis is placed on the publication of undergraduate research papers. BIOS is published four times a year.

# Contemporary Issues in Communication Sciences and Disorders

A scholarly journal maintained by the National Student Speech Language and Hearing Association that follows the policies and procedures of the ASHA Publication Board. Articles submitted to CICSD are reviewed by professionals in communication science and disorders and, when appropriate, professionals in related disciplines (e.g., linguistics, neurology and neuroscience, motor control, psychology). (CICSD) is an archival journal that publishes papers pertaining to the processes and disorders of speech, language, and hearing, and to the diagnosis and treatment of such disorders, as well as articles on educational and professional issues in the discipline. Submissions to CICSD are accepted from students as well as professionals.

### **Geographical Bulletin**

This scholarly journal is published twice a year by Gamma Theta Upsilon -International Geographic Honor Society. Articles concerning any area of geographical interest are solicited from students and faculty.

### **Geophysical Journal International**

One of the world's leading primary research journals in geophysics. The Board of Editors is international in representation. Promotes the understanding of the earth's internal structure, physical properties, evolution and processes. -- NEW! Student Author Award Scheme Designed to recognize and acknowledge the 'best papers' submitted to Geophysical Journal International from young scientists in the field, manuscripts are short listed by their high profile Editorial Board and highlighted on the Geophysical Journal International homepage. [To qualify, students are required to be the first author at submission].

### IMPULSE: An Undergraduate Journal for Neuroscience

The first international, online neuroscience journal for undergraduate publications. Submissions are reviewed by students worldwide under faculty guidance, and articles are immediately published online as they are accepted. Impulse encourages undergraduate students from every institution to compose quality research articles. Because most research done by undergraduates, whether to fulfill a thesis or major or to aid the research of other scientists, goes unwritten and unpublished, Impulse is the perfect outlet for undergraduates to engage in the process of writing and publishing and to become familiar with the complete process of scientific publication. Impulse is maintained at South Carolina Honors College.

### Journal of Mammalogy

The Journal of Mammalogy, American Society of Mammology's flagship publication, is produced six times per year. A highly respected scientific journal, it details the latest research in the science of Mammalogy. The ASM encourages undergraduate students to apply for the ASM Undergraduate Student Research Awards to be presented at the annual meeting of the Society. Membership in ASM is required for the undergraduate competition.

### Journal of Undergraduate Chemistry Research

[Virginia Military Institute] A peer review journal that will be published quarterly with papers of original research performed by undergraduates on all aspects of chemistry including analytical, organic, inorganic, physical, polymers and biochemistry. Authorship may be by the student or their professor. Submission implies that the material has not been published in or submitted to any other journal. Previous oral or poster session presentations should be footnoted. Copyright of the manuscript is transferred to the publisher upon acceptance.

### Journal of Undergraduate Research in Bioengineering

JURIBE showcases research results of undergraduate students in bioengineering. Completed research projects are not necessary for publication. Articles are intended to document research accomplishments to date. It is expected that many of the articles that appear in this journal will later be expanded to full length studies and published elsewhere. Publication in JURIBE will not preclude later publication of the results in a more complete presentation. Reports on original research are limited to research conducted while or before the author was an undergraduate. Maintained at Engineered Biomaterials, University of Washington

### Nanoscape

The Journal for Undergraduate Research in Nanoscience provides undergraduate students with opportunities to experience writing and submitting original research manuscripts to a peer-reviewed journal. It disseminates the results of undergraduate research in nanoscience and nanotechnology to the wider community, and encourages undergraduate involvement in research opportunities. Launched in 2004, Nanoscape is an educational outreach project of the Northwestern University Nanoscale Science and Engineering Center (NSEC) for Integrated Nanopatterning and Detection Technologies and funded by the National Science Foundation.

### RURALS: Review of Undergraduate Research in Agricultural and Life Sciences

A faculty-refereed journal devoted to the publication of high quality research by undergraduates worldwide in all research problem areas including, but not limited, to those described in the USDA, CSREES Manual of Classification of Agricultural and Forestry Research. Maintained at the Institute of Agriculture and Natural Resources at the University of Nebraska, Lincoln. Articles by graduate students will be considered if the work has been completed as undergraduates. Articles are instantly issued upon acceptance.

### Scientia et Humanitas: A Journal of Student Research

Scientia et Humanitas accepts original unpublished undergraduate and graduate research from the natural and social sciences and from the humanities from Middle Tennessee State University students and recent graduates either by themselves or in conjunction with a faculty mentor. The journal is a peer-reviewed publication of the University Honors College.

# **Mathematics**

# Furman University Electronic Journal of Undergraduate Mathematics

The Furman University Electronic Journal of Undergraduate Mathematics is an online-only journal designed to encourage undergraduate research in the field of mathematics. Its online nature allows quick publishing of mathematics papers, giving undergraduate students an opportunity to see their work published prior to their graduation. The Journal is refereed, and in addition each student or group of students submitting a paper must have a sponsor, who must be a full-time faculty member at a two or four year college or university.

## involve - a journal of mathematics

Dedicated to showcasing and encouraging high quality mathematical research involving students (at all levels). The editorial board consists of mathematical scientists each of whom is personally committed to nurturing student participation in research. A publication in between the extremes of purely undergraduate research journals, which in general are aimed at undergraduate audiences, and mainstream research journals. Such a venue is an important asset to mathematics researchers who wish to encourage the creative involvement of students in mathematical enterprises early in their careers.

# MEJAM - Morehead Electronic Journal of Applicable Mathematics

The Morehead Electronic Journal of Applicable Mathematics (MEJAM) is an interdisciplinary journal, sponsored by Morehead State University, which publishes the work of undergraduate students. The goal of MEJAM is to provide a refereed outlet for undergraduates in any discipline to publish quality papers and see the results quickly. MEJAM accepts papers which are outside the realm of the typical undergraduate curriculum and which emphasize the applicability of mathematics while maintaining significant mathematical interest. Papers may be historical, expository, or completely original in nature but must adhere to strict academic standards and should explore some aspect of the applications of mathematics.

# NEXUS Network Journal: Architecture and Mathematics On-line

A peer-reviewed scholarly journal for scholars and students engaged in the study of the application of mathematical principles to architectural design. It appears twice yearly in print and on the Internet, and is co-published by Kim Williams Books, Turin, Italy, and Birkhaeuser Publishers, Basel, Switzerland. Its goal is to present the broadest possible consideration of all aspects of the relationships between architecture and mathematics. A logo contest is sponsored each year.

### Pi Mu Epsilon Journal

The Pi Mu Epsilon Journal is interested in considering mathematical papers that may be of interest to readers of the PMEJ. Papers written by undergraduates are preferred. Submissions are accepted from any undergraduate student and membership in Pi Mu Epsilon is not a requirement. The Journal is maintained by the Department of Mathematics, University of North Carolina, Charlotte

### Rose-Hulman Undergraduate Mathematics Journal

The Rose-Hulman Undergraduate Mathematics Journal is devoted entirely to papers written by undergraduates on topics related to mathematics. Although the authors need not be undergraduates at the time of submission or publication, the work must have been completed before graduation. The journal will be distributed freely in an electronic format (PDF) from the journal's web site. In order to maintain a high level of exposition, each paper must be sponsored by a mathematician familiar with the student's work and each paper will be refereed.

### SIURO - SIAM Undergraduate Research Online

SIAM Undergraduate Research Online (SIURO) is a web-based publication devoted to undergraduate research in applied and computational mathematics. The publication represents a wide range of applied topics, including but not limited to, analysis, discrete mathematics, statistics, operations research, optimization, dynamical systems, modeling, and computation. Typical areas of application include but are not limited to, physical, life, financial, and management sciences and engineering. The Society for Industrial and Applied Mathematics (SIAM) is an international community of over 11,000 individual members, including applied and computational mathematicians, computer scientists, and other scientists and engineers.

# Psychology

## Journal of Psychological Inquiry

JPI encourages undergraduate students to submit manuscripts for consideration. Do not send manuscripts that have been accepted for publication or that have been published elsewhere. Undergraduate students from outside the Great Plains area are encouraged to submit to Special Features Sections of the Journal. Topics for these sections are designated. Maintained at the University of Nebraska at Kearney.

## Journal of Psychology and Behavioral Sciences

JPBS is an annual periodical published by the Psychology Department of Fairleigh Dickinson University at Madison, New Jersey. Articles in ANY topical area of psychology are considered including, but not limited to: Behavioral Neuroscience; Social; Sport; Industrial/Organizational; Clinical; Substance Abuse; Personality; Learning; Psychopharmacology; Health; Medical; Psychotraumatology; Cognitive, Developmental; Psychology of Women/Men; Cognitive; Developmental; Experimental; Humanistic; Transpersonal and Peace Psychology. Print and electronic.

## Psi Chi Journal

The Psi Chi Journal of Undergraduate Research is a national, fully reviewed, quarterly journal dedicated to the publication of undergraduate student research. The twofold purpose of the journal is to foster and reward the scholarly efforts of undergraduate psychology students as well as to provide them with a valuable learning experience. Submissions are accepted for review on an ongoing basis. Although manuscripts are limited to empirical research, they may cover any topical area in the psychological sciences. The primary author of a submitted manuscript must be an undergraduate student who is a member of Psi Chi.

# UJOP - Undergraduate Journal of Psychology

The Department of Psychology at the University of North Carolina, Charlotte, publishes the Undergraduate Journal of Psychology (UJOP). All undergraduate students are encouraged to submit their original research or literature reviews to the UJOP review committee. Several back issues are available online for comparison work.

# UCLA Undergraduate Psychology Journal

UPJ at the University of California Los Angeles is a publication which features outstanding research work performed by undergraduate students at UCLA and around the country. UPJ is an online journal actively seeking undergraduate research in all areas of psychology and related fields. Research should emphasize possible behavioral, psychobiological, cognitive, neurological, physiological, social, developmental, and/or emotional mechanisms behind psychological functioning. They invite papers that approach psychological issues from a wide variety of perspectives such as behavioral neuroscience, clinical psychology, cognitive psychology, developmental psychology, learning and behavior, measurement and psychometrics, and social psychology.

## The Yale Review of Undergraduate Research in Psychology (YRURP)

Welcomes submissions of research articles, literature reviews, and other scientific writing in the field of psychology. Journal staff are prepared to review submissions in the following areas: neuroscience (including behavioral and animal), clinical psychology, cognitive psychology/ cognitive science, developmental psychology, and social & personality psychology. The lead author must have conducted her or his research while an undergraduate (or equivalent) student at an accredited college or university anywhere in the world.

# Politics, Public Safety, and Law

Critique: a worldwide student journal of politics

Critique provides a forum for graduate and undergraduate students of politics to express and exchange diverse ideas and to imagine new possibilities for democracy and justice. The electronic format of Critique provides an alternative venue that expands political debate by creating space for the emergence of new ideas. Critique welcomes submissions year round from undergraduate as well as graduate students.

# The Dialectics: Undergraduate Journal of Leadership, Politics, and Society

The Dialectics is a refereed, multidisciplinary online journal devoted to undergraduate scholarship and discourse, is currently accepting high quality essays on issues of public importance. They search for papers that have a single thesis, are focused, identify significant societal and global issues, and offer creative solutions or specific recommendations for addressing the challenges. Students from undergraduate institutions in the United States or abroad are cordially invited to submit their work for review. Maintained at Penn State at Abington.

### Indigenous Law Journal

A student-run legal journal with a mixture of Aboriginal and non-Aboriginal staff. We are the first and only Canadian legal journal to exclusively publish articles regarding Indigenous legal issues. The Journal is dedicated to developing dialogue and scholarship in the field of Indigenous law both in Canada and internationally. Original, unpublished submissions are sought from academics, students, judiciary, practitioners, or anyone else writing in the area. The journal will publish scholarly works of any form. Articles, notes, comments, reviews, stories or other submissions are all encouraged. Maintained at the University of Toronto, Canada.

### IPE- Issues in Political Economy

IPE is committed to supporting and encouraging quality undergraduate research in all areas of economics. The Journal was founded on the belief that the best way to learn economics is to do economics. Through the process of research, writing, and peer review, students actively engage the discipline in a way not possible by simply listening to lectures and reading textbooks. In short, undergraduate research is a vital component in an economics education. The literature suggests that students take projects more seriously and learn more when the project is directed towards an external rather than an internal audience such as a class assignment. Though submissions on all topics in economics will receive consideration, papers should be analytical and seek to add new understanding to the topic. In 2007, the Journal became the first commercially distributed undergraduate periodical in the nation.

The forthcoming edition will be distributed among academics worldwide and sold in Barnes and Noble and Borders bookstores.

### On Politics

On Politics a journal published by the University of Victoria Undergraduate Politics Society. It seeks to provide an opportunity for undergraduate and master's level scholarship. While fully aware of the various concentrations available within contemporary political science, each issue of the journal is geared toward striking a balance between international relations, comparative politics, Canadian politics and political theory. The journal pursues academic scholarship that is mindful of the numerous theoretical orientations that may serve to enhance the structure of an argument. However, these orientations do not remain free from contention, and thus inter-theoretical debates are encouraged. With these broad aims and inclusive features, On Politics desires to present an accommodating format to disseminate scholarship of political nature from those who seldom gain the opportunity.

### Texas International Law Journal
