| Our Mission          | The mission of the Auburn University at Montgomery Alumni Association is to foster and strengthen the relationship between AUM and its alumni and friends; to preserve and promote the University's traditions, purposes, growth, and development; and to keep alive the spirit of affection and respect for our alma mater.   |
| Selection Process    | <ol> <li>Any AUM alumnus/alumna wishing to serve on the AUM Alumni Association Board of Directors may submit an application by September 15, 2025.</li> <li>Candidates will have the opportunity to meet with current Board members at an informal mixer event in late September (invitation to follow).</li> <li>All applications will be reviewed by the Nominating Committee. Further interviews with applicants may be conducted if needed.</li> <li>By early October, the Nominating Committee will prepare a slate of officers for the 2026-2027 term.</li> <li>The proposed slate will be submitted for a vote from the AUM Alumni Association Board of Directors in October and, if approved, will be installed at the next board meeting in January 2026.*</li> <li>*Candidates are chosen based on strengths and experience that align with the current needs of the association. Any applicants not selected for a Board position will be retained on file for future consideration.</li> </ol> |
| Eligibility          | <ul> <li>Only active alumni shall be eligible for nomination and election as members of the Board of Directors.</li> <li>Directors shall receive no compensation for their services, nor shall any director be reimbursed for any expenses incurred in attending regular, annual, or special meetings of the Board.</li> </ul>   |
| Term of Office       | -Two years (except for the ex-officio members who serve one-year renewable terms) Elected at the October 2025 Board of Directors meeting and installed at the January 2026 meeting.  |

|                        | - Directors may serve a maximum of two consecutive two-year               |

|                        | terms in the same position. Following two terms, the Board member         |
|                        | then must rotate off the Board for a minimum period of one year or        |
|                        | serve in a new role on the board. After a one-year period of absence      |
|                        | from the Board, a former Board member may reapply for                     |
|                        | consideration to serve another two-year term as a director.               |
| Fundraising            | All Board members are encouraged to make an annual gift to AUM.           |
|                        | Amount and designation is at the discretion of the Board member. Our      |
|                        | goal is to have 100% participation from the Board each year.              |
| Time requirements      | We require a time commitment of approximately 35-40 hours per year        |
|                        | for board meetings; committee meetings as needed; special meetings;       |
|                        | and Alumni Association sponsored events. We cannot serve our fellow       |
|                        | alumni well or meet deadlines without full participation from all Board   |
|                        | members.  |
| Board Meetings         | The full Board meets three times per year on AUM's campus, usually        |
|                        | on a Friday in January, June, and October at 11:30 am.                    |
| Committee Meetings     | Committees meet at the pleasure of committee members in order to          |
|                        | accomplish certain tasks by established deadlines. Attendance is          |
|                        | essential for the committees to complete their objectives.                |
| Board Meeting Planning | All Board members are expected to attend a Board Planning Meeting         |
|                        | (typically over dinner) to discuss plans for the upcoming year. This      |
|                        | meeting is held on a weeknight in the fall before the first regular Board |
|                        | meeting in January.   |
| Other Requirements     | Board members are strongly encouraged to support all AUM Alumni           |
|                        | Association activities and events with attendance at a minimum of         |
|                        | 50% of activities throughout the year. Board members are also             |
|                        | frequently invited to attend and volunteer at special campus events as    |
|                        | Alumni Association representatives and are encouraged to do so as         |
|                        | their schedule allows.  |
